TOWN BOARD MEETING
TOWN OF HARRISON, LINCOLN COUNTY

December 12, 2022

Meeting was called to order @ 6:30 p.m. by Chairman Hanson.

Members present: Chairman Hanson, Supervisor Daigle, Supervisor Goes, Clerk Voermans, Treasurer Boyle joined virtually

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2nd by Supervisor Daigle to approve minutes from November meeting. Motion carried.

Motion by Supervisor Goes – 2nd by Supervisor Daigle to approve treasurer’s report as given by Clerk Voermans. Motion carried.

Update given by board members on road issues.
Chairman Hanson gave update on Woodford Road bridge.
Speed limit on Pickerel Lake Road was discussed. Need more input.

Clerk Voermans received a building permit application for Dave Thirsten. The site does land within shoreland zoning. Property owner will be notified of such and ask to contact Lincoln County zoning for a land use permit.

Chairman Hanson explained the over spending on the highway budget. No questions followed.

No updates on the internet advisory committee as they did not have a meeting this month.

Motion by Chairman Hanson – 2nd by Supervisor Goes to accept bid for new furnace from Premier Heating in Tomahawk. Motion carried. Cost of furnace is \$4,935.00. ARPA money will be used for this.

Motion by Chairman Hanson – 2nd by Supervisor Goes to make the following changes for the town employee wages:

Highway crew - \$30/hour - was \$17.50/hour

Park crew - \$18/hour – was \$17.50/hour
Election inspectors - \$15/hour – was \$12.00/hour
Chief inspector – additional \$25/day – was \$20/day

Motion by Chairman Hanson – 2nd by Supervisor Daigle to raise the permit fees from \$20 up to \$30. Motion carried.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to approve purchase of printer toner for the clerk’s printer. Motion carried. Cost is roughly \$1,000. ARPA money will be used for this.

Caucus date is set for Saturday, January 21, 2023 at 9:00 a.m.

Items for next month’s meeting: broadband ordinance/Woodford Road bridge/Bathrooms – Pine Lake beach/highway maintenance contract/internet advisory committee/Callahan Road

Motion by Supervisor Daigle – 2nd by Supervisor Goes to approve payment of bills. Motion carried.
