# Yellow Internet Sign Ads:

- Bob reports the contact is an out of state person representing "All Choice" sellingn satellite (Viasat & Hughes) internet. The offer is \$60 per month for three months, then \$100 per month with a two-year contract commitment. They claim 25 down and for more \$ possibly 100mbps Signs are everywhere.
- It appears the new FCC maps may not be out by November.
- Per Ken, signs are not legal if posted on road right-a-way
- We could include this information on our FB page

#### Maps:

Steve reports there are more households in a census block than the census blocks indicate which means more potential customers for the Service providers and a more attractive business model. We will wait to see if the County GIS can possibly do map overlays to show actual residents in census blocks.

## **County Board:**

Ken reports he has scheduled the Charter Project Manager at the next County Board meeting October 13th and to get plans to obtain specific information for Harrison and King regarding covered and uncovered areas. Charter created a separate division in their company to manage the large number of Rural Digital Opportunity funds (RDOF) areas they were awarded. They have six years to complete the work. They consider this year one. Other information we want to know is: what are their timelines, where do they start, when will we be on the schedule, and what about the areas outside of RDOF.
