Chairman Hanson gave update on invasive Japanese knotweed on Lon Basco Lane. The weeds were cut and sprayed. The work is done for the year.

Update given by Sheriff Hartman as to why they would like to increase the contract for ambulance service. The least the contract would change is 4% and the most would be 10%. He will send new contract for the board to review.

Discussion was held on salaries for the board.
