TOWN BOARD MEETING
TOWN OF HARRISON, LINCOLN COUNTY
HARRISON TOWN HALL
March 13, 2023

Meeting was called to order @ 6:30 p.m. by Chairman Hanson.

Members present: Chairman Hanson, Supervisor Daigle, Supervisor Goes, Clerk Voermans, Treasurer Boyle

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2nd by Supervisor Daigle to approve minutes from February meeting. Motion carried.

Motion by Supervisor Goes – 2nd by Supervisor Daigle to approve treasurer’s report. Motion carried.

Treasurer Boyle reported Crossbridge Community Bank has new CD rates higher than what we have now and recommended to move the CD’s. The new rate is 3.25%.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to move the 3 CD’s to a 6 month CD @ 3.25%. Motion carried.

Update given by board members on road issues.

Supervisor Daigle stated he talked with Any Tomaszewski from the Town of King and at this point the Town of King has no desire to pave Callahan Road.

Chairman Hanson gave update on Woodford Road bridge. The application is already to go and must be submitted by 3/24/23.

Road limits will be posted and effective Wednesday, March 15, 2023 at noon.

Motion by Chairman Hanson – 2nd by Supervisor Goes to grant permission to Junior Howard to use County Old A Road after road limits are posted. Junior Howard has signed a contract to fix any damage if need be.

Motion by Chairman Hanson – 2nd by Supervisor Goes to approve beaver contract with USDA and to pay the bill when a new one is submitted. Motion carried.

Chairman Hanson negotiated the contract and agreed to \$1,125.00.

Supervisor Daigle stated nothing to report on bathrooms at Pine Lake beach at this time.

Pat Voermans gave update on internet advisory committee.
