August 12, 2025

Meeting was called to order @ 6:00 p.m. by Chairman Hanson.

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2nd by Supervisor Daigle to approve minutes from July meeting. Motion carried.

Motion by Supervisor Daigle – 2nd by Supervisor Goes to approve minutes from Board of Review. Motion carried.

Motion by Supervisor Daigle – 2nd by Supervisor Goes to approve treasurer's report. Motion carried.

Updates given by board members on road issues.

Gouda, MT&W, and Stone Creek Roads were all chip sealed on August 11, 2025.

Supervisor Daigle informed Jason Lemmer the town might be interested in doing Keg Road and Sandhill Road next year when the county does Highway D. Jason will be in contact with the town.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to have Musson's brush Hobie Road and Dump Road with their boom equipment. Motion carried. Cost is approximately \$2,000.

Town will come up with a plan on the maintenance of Mail Route Road, Woodford Road, Squaw Lake Road and Noisy Creek Road.

The town will consider mowing the town roads twice a year if the needed, especially the main roads. Chairman Hanson recommended culvert replacement and turn around repairs on Hanson Road.

Spray patching is done on Bear Trail.

The road crew will take a look at the limbs on the road on Pine Lake Road.

Re-cap on recycling day - \$486 was collected and there was no charge to the town for the dumpster.

Playground equipment definitely needs attention.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to approve Resolution 2025-03 and Resolution 2025-04. Motion carried. Resolutions are for Lincoln County Zoning. They are on file with the clerk.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to approve Harrison Hills ATV Club to use ball park parking lot on Oct. 4th. Motion carried.

Community work group will meet on Monday, August 17th.

Motion by Supervisor Daigle – 2nd by Chairman Hanson to approve Revaluation for 2026 with Associated Approval. Motion carried. Revaluation will be \$70,000 and \$15,000 for maintenance.
