

RESOLUTION 2025-03

ORDINANCE AMENDMENTS WHICH CREATES REVISIONS TO LINCOLN COUNTY ORDINANCES RELATED TO MINOR EDITS FOR LICENSE AND PERMITS, ZONING CODE, SUBDIVISION AND PLATTING, SHORELAND ZONING, AND PRIVATE SEWAGE SYSTEMS.

1. WHEREAS, §59.69(5), Wisconsin Statutes, describes a procedure for preparing revisions to an existing county zoning ordinance, involving approval by both the County Board of Supervisors and a majority of Town Boards affected by the amendments; and
2. Whereas, §295.14, Wisconsin Statutes, gives authority to enact and administer a nonmetallic mining reclamation ordinance
3. WHEREAS, §236.45(4), Wisconsin Statutes, describes a procedure for preparing revisions to an existing county subdivision ordinance, involving approval by both the Land Services Committee and the County Board of Supervisors; and
4. Whereas, §59.692, Wisconsin Statutes, gives authority to Lincoln County implement §59.692 and §281.31 regarding Shoreland Zoning.
5. Whereas, §59.70(5) and 145.01(5), Wisconsin Statutes, gives Lincoln County the responsibility to regulate private on-site wastewater treatment systems.
6. WHEREAS, Lincoln County has prepared revisions to the Lincoln County Ordinances related to the following sections (see attached table A) of the Lincoln County Code of Ordinances and is effective in the Town of Harrison; and


