

**MINUTES**  
**TOWN BOARD MEETING**  
**TOWN OF HARRISON, LINCOLN COUNTY**  
**HARRISON TOWN HALL**  
**June 10, 2025**

Meeting was called to order @ 6:00 p.m. by Chairman Hanson.

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2<sup>nd</sup> by Supervisor Hanson to approve minutes from May meeting. Motion carried.

Chairman Hanson will do some research on the records request Clerk Voermans received from SunLight.

Motion by Supervisor Goes – 2<sup>nd</sup> by Chairman Hanson to pay for the damage to Randy Schmidt's truck while on the job. Motion carried.

Randy Schmidt stated he got the book library installed on the town hall.

The Harrison history social went well.

Clerk Voermans stated Spectrum internet has been installed on Squaw Lake Road.
