May 13, 2025

## Immediately after 1st Board of Review

Meeting was called to order @ 6:02 p.m. by Chairman Hanson.

Members present: Chairman Hanson, Supervisor Daigle, Clerk Voermans, Supervisor Goes, Members absent: Treasurer Boyle

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2<sup>nd</sup> by Supervisor Daigle to approve minutes from April meeting. Motion carried.

Motion by Supervisor Daigle –  $2^{nd}$  by Supervisor Goes to approve minutes of annual meeting with the following change. Chairman Hanson asked to edit the minutes to reflect the motion on speed limit on Parrish Road as an advisory vote only. Motion carried. Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve minutes from special meeting on April 23. Motion carried.

Motion by Supervisor Daigle  $-2^{nd}$  by Supervisor Goes to approve treasurer's report as given by Clerk Voermans. Motion carried.

Updates given by board members on road issues.

Supervisor Goes stated potholes & asphalt repair will start next week.

Some oil was spilled on Callahan Road. Town of King was concerned. Board members checked it and all looks good.

The board members will split up the town roads for road inspections and each will take a section.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to move forward with the maintenance list. Motion carried.

There was a request to not grade Stone Creek Road so they can use strollers on it. A discussion was held. Grading will continue as the road needs to be maintained. Motion by Supervisor Daigle – 2<sup>nd</sup> by Chairman Hanson to post the speed limit on Parrish Road for UTV/ATV use as such: 25 mph on blacktop and 35 mph on gravel. Motion carried. Speed limit on Beaver Trail Road was discussed and tabled.

Chairman Hanson gave update on Bear Trail Road. Phil Kriesel from MSA and Chairman Hanson met and walked the road. Phil gave recommendations to Chairman Hanson. Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve 25 loads of gravel for each Bear Trail & Turtle Lake Road. Motion carried. Bowen's will be doing the work.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Daigle to approve building permit for Tom & Sue Schoone. Motion carried.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve building permit for Derek & Tessa Funk. Motion carried.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve building permit for Scott & Jennifer Brock. Motion carried.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve purchase of a generator. Motion carried. Price is not to exceed \$9,100.00

New chairs for the town hall is tabled at this time.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve cleaning of ball park bathrooms. Motion carried. Cost is \$100/occurrence. It will be 2/month and then once a month as needed.

Record request fees were discussed. Clerk will check minutes to find previous rates. Rates should match the county rates.

Motion by Chairman Hanson –  $2^{nd}$  by Supervisor Daigle to approve Ordinance # 01-2025. Motion carried. Ordinance is the approve the town clerk to be a member of the Board of Review.

Jack Van Ryen recommended to have the playground equipment at the ball park updated. Supervisor Daigle will look at it.

Jerry Schoone recommended price check for the recycling day. Prices were higher last year. Junior Howard is already booked for this year. Will check for next year.

Supervisor Goes recommended to plant a tree for the Christmas tree. Thank you to Jack Van Ryen for selling the old lawnmower. Sold for \$525.
