**HARRISON TOWN HALL**  
**October 14, 2025**

Meeting was called to order @ 6:00 p.m. by Chairman Hanson.

Members present: Chairman Hanson, Clerk Voermans, Treasurer Boyle, Supervisor Goes  
Members absent: Supervisor Daigle

Pledge of Allegiance was recited.

Motion by Supervisor Goes – 2<sup>nd</sup> by Chairman Hanson to approve minutes from September meeting. Motion carried.

Motion by Supervisor Goes – 2<sup>nd</sup> by Chairman Hanson to approve treasurer's report.  
Motion carried.

Updates given by board members on road issues.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve Corey Shortridge as a new town employee. Motion carried.

Chairman Hanson gave update on Japanese knotwood growing again on Lon Basco Lane. It was treated again.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve gravel for R&H Road not to exceed \$9,900. Motion carried. This will be split with the Town of Russell.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve spray patch on Gartman, Oak Ridge & Plantation Roads. Motion carried. Estimate is \$6,000.

Chairman Hanson checked with Junior Howard and no garbage is being dumped in the construction landfill. Trucks are being parked there.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve building permit for Chad McCartney. Motion carried.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve building permit for Joe Hilgendorf. Motion carried.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve building permit for Linda Metz. Motion carried.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve driveway permit for Karl Hansen. Motion carried.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to deny operators permit for Michelle Gardner from Winding Trail based on background check. Motion carried.

Chairman Hanson gave update on enforcement of the wake enhancement ordinance. He is working with Lincoln County on this.

Clarification on the revaluation contract was discussed. \$40,000 in due in 2026 and the remaining balance of \$30,000 is due by 1/31/2027.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to approve purchase of rubber mulch for the playground area at the ball park. Motion carried. Estimate is \$2,500.

The community workgroup is having a pie/ice cream social at the town hall on Sunday, Oct. 26 from 1-3 p.m. All are invited.

Motion by Supervisor Goes – 2<sup>nd</sup> by Chairman Hanson to approve payment of bills. Motion carried.

Next meeting – Tuesday, November 11, 2025 @ 6 p.m. starting with the budget hearing, followed by special electorate meeting and then regular town meeting.

Motion by Supervisor Goes – 2<sup>nd</sup> by Chairman Hanson to adjourn. Motion carried.
