Meeting was called to order @ 6:00 p.m. by Chairman Hanson.

Pledge of Allegiance was recited.

Motion by Supervisor Daigle -2^{nd} by Chairman Hanson to approve minutes from August meeting. Motion carried.

Motion by Supervisor Daigle – 2nd by Chairman Hanson to approve minutes from August 25, 2025 special meeting. Motion carried.

Motion by Supervisor Daigle – 2^{nd} by Chairman Hanson to approve treasurer's report. Motion carried.

Updates given by board members on road issues.

Dump Road will not be brushed by Musson's. It will be properly mowed and then town employees will brush it.

Town will get an estimate on Bear Trail Road for a possible guard rail.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to approve building permit for Kurt & Kay Ross. Motion carried.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to approve building permit for Pat & Jane Cook. Motion carried.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to approve building permit for Spectrum pending payment. Motion carried.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to tentatively approve driveway permit for Andrea Swoboda as long as they make driveway 20' wide. Motion carried. Driveway at this point is only 10' wide.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to approve operators permit for Lisa Lee from Winding Trail. Motion carried.

Chairman Hanson gave update on enforcement of the wake enhancement ordinance. He will ask the county formally to help enforce the ordinance.

The playground equipment definitely needs to be replaced. Form committee and research some new equipment.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to approve contract with Tripoli Propane. Motion carried. Contract is for \$1.49/gallon.

Motion by Chairman Hanson – 2nd by Supervisor Daigle to approve payment for rental vehicle for Randy Schmidt. Motion carried. Cost is approximately \$300.00.

Community workgroup is meeting monthly. On October 26^{th} , they will be hosting a pie and ice cream social from 1-3 p.m. at the town hall. They are planning a fall market for next year.

Lawrence Schoone expressed concerns with Howard Disposal garbage trucks coming off Old County A Road wondering if they are dumping in the construction pit. Chairman Hanson will check on this.

Motion by Chairman Hanson – 2^{nd} by Supervisor Daigle to approve fire contract with the Town of Crescent. Motion carried. Contract has increased \$500.

Clerk Voermans informed the board Oneida County landfill will be increasing prices.
