Meeting was called to order @ 6:37 p.m. by Chairman Phelps.

Pledge of Allegiance was recited.

Motion by Supervisor Hanson - 2nd by Supervisor Schoone to approve minutes from March meeting. Motion carried.

Treasurer's report given by Clerk Voermans.

Motion by Chairman Phelps - 2nd by Supervisor Hanson to approve Jerry Schoone, Pat Voermans, and Judy Schoone as board of review alternates. Motion carried.

Motion by Supervisor Hanson - 2nd by Supervisor Schoone to approve fire contracts for Tomahawk Fire Dept. and Town of Russell Fire Dept. Motion carried.

Discussion was held regarding signs on the ball park. Chairman Phelps will check on this.

The town will continue to improve Pine Lake beach. DNR will be contacted when weeds appear.

Motion by Supervisor Hanson - 2nd by Chairman Phelps to put 3-5 loads of gravel on parking lot at ball park. Motion carried.

Motion by Supervisor Schoone - 2nd by Supervisor Hanson to allow public to get wood chips from ball park.

Motion by Supervisor Schoone - 2nd by Supervisor Hanson to buy 4 barricades from Highway Maintenance. Motion carried.
